# 1. Total Compensation

This includes pay codes on an employee's check that are earnings, add to net pay, or are included for tax purposes.

# 2. FFCRA Expenses

This includes wages or healthcare costs entered in payroll for claiming the FFCRA tax credit.

#### 3. ERC Expenses

This includes wage amounts or healthcare costs entered in payroll for claiming the Employee Retention Credit.

# 4. Potential Wages

This includes FICA-taxable wages paid by the employer. This does not include wages used for FFCRA or Employee Retention Credit. Any transportation benefits or dependent care assistance paid above the FICA exempt limit are also not included.

These are wages that may be eligible for Employee Retention Credit. If you paid transportation benefits or dependent care above the FICA exempt limit, you can add those amounts in. Work with your financial advisor to determine eligible wages.

If you entered Employee Retention Credit as a lump sum in payroll, or the employee has met or exceeded the limit, the Potential Wages might not reflect actual amounts that can be used. Potential Wages don't account for the limit, and you'll need to consider wages across the entire period.
