#### 1. Cash Compensation

Includes salary, vacation, leave (sick, parental, family, and medical), severance pay, wages, commissions or similar compensation, hazard pay, bonuses, and cash tips or the equivalent. Not included: non-cash fringe benefits like company cell phones. Wages paid under FFCRA or used toward Employee Retention Credit are also excluded – these are not eligible for forgiveness. Each employee's cash compensation is capped at \$100,000 annualized for your covered period.

Wages eligible for forgiveness include both:

- Wages paid on a check date during the covered period (even if earned before the covered period)
- Wages earned during the covered period, but paid afterward

#### 2. Other Payroll Costs

Columns H through J come from processed payrolls. Here are a few highlights:

- Taxes (column H) are generated based on payroll processing.
- If employer retirement costs are tracked through payroll, these display in column I.
- If you use Paychex Insurance Agency for Health and Benefits, these expenses display in column J. Healthcare expenses used toward FFCRA or Employee Retention Credit are subtracted. If you don't use Paychex Insurance Agency, this may be a negative number.

#### 3. Full-Time Equivalents (FTEs)

The Estimator and report use the Avg. FTEs Simplified Method, found in column P. For detailed information on FTE calculations, see the <u>PPP Forgiveness Instructions</u>.

#### 4. Over 100K for Any 2019 Pay Period

Employees marked "Yes" earned an annualized amount of more than \$100k in any pay period in 2019 (for example, they were paid over \$1923.07 in any one-week pay period or \$3846.15 in a two-week pay period). When this is true, these employees are not evaluated for wage reductions.

### 5. Elapsed Covered Period Wage Reductions

This is the amount that wages or salaries were reduced in excess of 25% during the covered period when compared to the last full quarter prior to the covered period for employees who did not make over 100K annualized for any pay period in 2019. For detailed information, see the PPP Forgiveness Instructions.

## 6. Reference Quarter Wages & Covered Period Wages

The number you see here reflects the wages earned during the relevant time period. Unlike Cash Compensation, FFCRA and Employee Retention Credit wages are included, but irregular pay items such as bonus, tips, over time, and commission are not. These figures are needed as documentation.
